ICOM's code of ethics

2.20 Documentation of Collections Les Documentation of Collections Museum collections should be documented according to accepted professional standards. Such documentation should include a full identification and description of each item, its associations, provenance, condition, treatment and present location. Such data should be kept in a secure environment and be supported by retrieval systems providing access to the information by the museum personnel and ather legitimate users.

ICOM code of ethics for museums, 2006



Pros and cons (of having ICOM's code of ethics)

- Obligatory for ICOM members
- Does mention documentation
- What, but not why or how
- Limits scope to collections
- Implicitly restricts public access
- No mention of adequate means...
- Critical choices with limited budgets?

The need for documentation

documentation cannot be considered to be true museum collections.

If museums do not document

they cannot be adequately safeguarded and cared for
 the museum cannot domonstrate local account bills.

the museum cannot demonstrate legal accountability
their value for research and interpretation is greatly reduced

Practical benefits of good documentation


Evidence of ownership

- Information about each object's history
- Unique identification of each object
- Ease of location
- Access to descriptions which help with the recovery of stolen objects
- Control over intellectual property rights issues
- Access to research and publications relating to the collection
- Supporting information about themes of relevance to the collection
- Material for educational purposes and exhibitions
 Guidance on procedures and decision-making
- A full audit trail of work done on the collections
- Information about alienated objects
